## TO ALL WATERCRAFT LAUNCHING AT PERKINS ROAD

Be aware area is under video surveillance. Your misuse may result in a fine, and/or banned from use.

- Ramps are for launching only, not other recreational uses including No taking turns of any watercraft particularly Jet Skis.
- 2. No launching or recovery Sunset to Sunrise.
- 3. No Skiing, Swimming or fishing from ramp areas.
- 4. No powering on or off trailers.
- No starting or running of watercraft engines out of water, including jet skis.
- 6. No alcohol at the ramps.
- 7. All no wake zones must be obeyed.
- 8. No parking at ramps without a trailer. Parking of vehicles and watercraft trailers for use of ramp on adjacent streets is also prohibited.
- 9. No anchoring or mooring within 100 feet from ramp.
- 10. No fueling allowed at the ramps for any watercraft.
- 11. Idling at the boat ramps is prohibited.
- 12. No draining, cleaning, washing, repair or servicing of watercraft at the ramps.
- 13. No discharging of bilge pumps or popping of drain plugs at the ramps or in the water.

- 14. An adult must accompany persons under the age of 16.
- 15. No littering or disposing of food or beverages in the water.
- 16. All watercraft must be 20 feet in length or less. Watercraft over 20 feet must use Randolph Avenue Boat Ramp.
- Be courteous of neighbors as to noise levels and all applicable noise ordinances must be observed.
- 18. No trespassing on adjacent properties.
- 19. Dogs must be on leashes.
- No commercial use for demos or sale or any other commercial use.
- 21. No vehicles with loud exhaust system or no exhaust.
- 22. No spinning of tires or rubber on ramp.
- 23. No picnicking or fires.
- 24. Use by residents or non-residents without a permit may be towed at owners expense and \$150 fine.
- 25. No profanity or loud music.
- 26. Breach of rules may be subject to a fine of stiff sanction-\$150 and banning use of ramp and loss of permit.

I certify have been provided with a copy of the rules and regulations pertaining to the usage of the Perkins Boat Ramp and understand that failure to comply with the rules and regulations may result in fines and/or revocation of the permit.

I certify that I will protect the water quality of the Conway Chain of Lakes. I also agree to operate my watercraft in a safe and courteous manner. I certify that my watercraft engine is in good working condition and does not leak fuel or oil.

I, the undersigned, affirm that the information set forth below is correct and agree on behalf of myself and my passengers to adhere to the rules and understand all consequences of misuse.
